

MINUTES BOARD OF TRUSTEES MEETING Laidlaw Center Board Room Wednesday, July 21, 2010 2:00 p.m.

CALL TO ORDER Chair Chuck Robinson officially called the meeting to order at 2:04 p.m. Present were trustees Barbara Rofkar, Sue Cole, Steve Adelstein, and Tim Douglas, constituting a quorum. Board Chair Robinson recognized Trustee Sue Cole for her excellence in service as chair of the WCC Board of Trustees from July 1, 2009 through June 30, 2010. A gift of appreciation was presented which was acknowledged with thanks by Trustee Cole. A short recess was called and the meeting resumed at 2:10 p.m.

STRATEGIC DISCUSSIONS

→ WWU Draft White Paper on Waterfront Development – Vice President for University Relations Steve Swan, Western Washington University

Dr. Swan shared that WWU's position on the Bellingham waterfront development project has changed from its original inception several years ago due to the current economic conditions. In the draft white paper on the waterfront development, Western Washington University envisions a shared concept project with regional partners resulting in a community learning center featuring collaborative educational opportunities to meet institutional and local needs. Discussions continued on the value of waterfront development, partnerships, community access and other related topics. The next steps for WCC would involve consideration of becoming involved with a waterfront presence and assessment of any benefits.

The Plan will be presented to the Board at the regularly scheduled September Board meeting.

- → The President shared information regarding recent grants that have been awarded including a 2010-11 Campus Compact Retention program with a objective to improve retention and academic advancement rates of high risk students in middle school-college; and a US Department of Agriculture award to the NW Economic Council to promote the success of innovative start up businesses in Whatcom County. Whatcom CC and BTC are key players in the project.
- → The college was pleased that Tran Phung, physics instructor, was recently honored by WA Campus Compact for supporting her students' involvement in community organizations and for increasing service learning in the physics curriculum.
- ★ Kathi reported that the College is sponsoring a Classified Employee Appreciation and Professional Development Day, the first in the college's history, which will be held on August 12th at the Bellingham Cruise Terminal. The professional development committee, chaired by Cindy Hoskins, is developing a comprehensive program, and administrators and exempt personnel will be covering the basic college operations for the day.
- → President Hiyane-Brown shared that she is one of 10 women being honored at the Women of Color Empowered in Education luncheon, in Seattle in September. Trustees were invited to attend and the Foundation will coordinate the tickets for the event.
